P214579/PBA - 1a New Road, Bromyard, HR7 4AH

Application to determine if prior approval is required for a proposed Change of use from Commercial, Business and Service (Use Class E) to Dwellinghouses (Use Class C3) to include minor alterations, to facilitate the inclusion of the now redundant Taxi Office (Commercial Use) into the envelope of the existing residential use. The garage will remain as is. Type: (Part 3) Class MA

2. P214123/F - Tower Lodge, 15 Linton Lane, Bromyard, HR7 4DQ

Re-development to include alterations and extension to existing dwelling together with construction of 2 no. further residential dwellings.

Members considered this application, and the following issues were raised.

- Access lane to the site is narrow and unsuitable for use by heavy construction vehicles.
- Development of this nature is not permitted until the high levels of phosphates and nitrates are reduced in the River Lugg catchment area.
- The watermains serving this area is known to have minimal pressures at times of peak times and any increased demand would exacerbate the situation and adversely affect services to existing customers.

When considering the site plans and drawings members concurred that the proposals appear to be overdevelopment of this site.

IT WAS RESOLVED to object to this application for the reasons as listed above.
