P22/23 Planning Applications

To comment on planning applications to be determined by Herefordshire Council: -

1. P221095/J - 4 Porthouse Rise, Bromyard, HR7 4FS

Proposal of works to 1x Red Oak. General maintenance to include minor crown reduction of 1-2m to maintain size and prevent encroachment on the building. Removal of lower branch growing beyond boundary and beginning to encroach on highway. Other maintenance including deadwood and removal of ivy.

2. P214154/L - Sherford House, 34 Sherford Street, Bromyard, HR7 4DL

The works relate to a section of existing brickwork boundary wall to the east elevation.
