Following discussion, **it was RESOLVED** to enter into a 3-year agreement with Aviva Ltd., for a total first year premium of £8,135.61 commencing 26<sup>th</sup> May 2023, with a 5% rating escalator for subsequent years.

#### C23/62 Full Term Elections

At the full-term elections held on 4<sup>th</sup> May 2023, an insufficient number of candidates stood to fill all 18 seats on the Town Council. Herefordshire Council has advised that the Council may co-opt persons to fill the remaining seats.

West ward (14 seats) – 2 vacancies East ward (4 seats) – 3 vacancies

Members were reminded that:

- All new Councillors will need to <u>register their interests</u> within 28 days of their election. Whilst there is no legal requirement for re-elected members to complete a new form, they are encouraged to do so to ensure that their register accurately reflects their current registrable interests.
- All Councillors must make a <u>return and declaration</u> of their election expenses (even if nil) to the Proper Officer of Herefordshire Council by 1<sup>st</sup> June 2023. Failure to do so is an illegal practice and penalties may apply.
