No interests were declared at this point in the meeting.

C23/65 Public Question Time

A member of the public informed the meeting that he and a small group of local businesspeople had set up a Community Benefit Society and were in the process of taking over a commercial business unit as a community asset with private investors and setting up a community shop in the town.

Referring to C23/70,10., a resident of Old Road informed the meeting that she was not in favour of parking meters but would support a residents parking scheme.

Also referring to C23/70, a member of the public spoke about a general lack of maintenance in the town and suggested ways in which it could be addressed including setting up a working group to look at a more proactive approach to the upkeep of the town.

A member of the public asked for update on the installation of double yellow lines at the entrance to Kirkham Gardens and was advised that it was on Herefordshire Council's Traffic Regulation Order (TRO) waiting list. The Town Clerk to seek an update from Herefordshire Council.

It was RESOLVED to move item C23/70 forward in the order of business for the benefit of members of the public in attendance.

C23/70 Herefordshire Council Market Town Maintenance Fund

Members further considered suggestions for potential maintenance projects for inclusion in the Market Town Maintenance Fund list for the 2023/24 financial year. Members were reminded that Herefordshire Council has allocated a budget of £200k for each Market Town for this purpose.

The following items had been previously agreed by Full Council (Minute C23/17 refers).

- Replacement of all degraded or damaged street signs and street furniture within the town.
- Replacement of the dilapidated rail at the bottom of Clover Road

The following items had been put forward by Councillors for consideration (Minute C23/37 refers):

- Resurfacing of Church Lane, Bromyard
 It was RESOLVED not to include this item as it would be cost-prohibitive.
 It was further RESOLVED that investigations be made into costs for partial re-surfacing of Church Lane for those areas in need of repair.
- 2. Dropped kerbs on the A44 top of Clover Road (between the bus stops on either side of the road)
 - It was RESOLVED that this item be included.
- 3. Double yellow lines to stop parking at the entrance to Kirkham Gardens This item was not included as it would require a TRO and is already on the Herefordshire Council waiting list.
- 4. Pelican crossing outside the Co-op on Tenbury Road This item was not included. There was some uncertainty as to whether this was to be delivered via s106 allocations linked to the Porthouse estate. Ward Cllr Peter Stoddart to be requested to provide an update on this matter.
- Removal of pavement clutter in town to permit free use of pavement by mobility scooters.
 This item was not included as it was felt that this was a matter of enforcement rather than maintenance. The Town Clerk was requested to ascertain what Herefordshire Council's policy is on this issue.
- Repair seat/bench at Kirkham Gardens Not included. Does not fit fund criteria.
- 7. Map display of flat numbers at Kirkham Gardens Not included. Does not fit fund criteria.

 Item withdrawn. Does not fit fund criteria.
