C23/73 Declarations of Interest and written requests for dispensations

Local Authorities (Model Code of Conduct) Order 2007 SI No. 1159

C Dunne-Thomas declared an Other Registrable Interest in agenda item C23/82,5.2 as a resident of Frog Lane.

Cllr Holman declared an Other interest in C23/90 as a volunteer at Bromyard Youth Hub.

C23/74 Co-option

C23/90 Correspondence

The Chairman read out a written report from the SNT covering drug related matters, fraud offences and speed enforcement. The Community Speed Watch project is making progress and training is expected to begin in the coming months subject to a minimum of six volunteers being in place.

TM 23/24 Request for installation of double yellow lines in Bramley Orchards.

C23/83 Consultations

1. Traffic Regulation Order Scheme to implement alterations to the existing parking arrangements on various roads, Bromyard, Herefordshire.

A Statutory Consultation Letter and Proposal Plans had been circulated with the agenda. Closing date for comments: noon on Tuesday 8th August 2023.

The measures are proposed for the following reasons:

- To provide an additional Disabled Parking Bay on Broad Street, without decreasing the existing Limited Waiting parking provision on-street.
- To make the maximum stay time permitted for the limited waiting provision on Church Street consistent with the rest of the town.
- To prevent inconsiderate and inappropriate parking, double parking, improve road safety and amenity, prevent parking close to junctions and where it causes obstructions for large vehicles (inc. emergency service vehicles) and cyclists.
- To remove an advisory Keep Clear marking from New Road as it is no longer required.

Following discussion, **it was RESOLVED** to support the above alterations to existing parking arrangements in Bromyard.

2. West Mercia Police and Crime Commissioner – Town and Parish Council Survey 2023.

Members were requested to complete a survey on police visibility, accessibility and crime and disorder in the Bromyard area, copies having been circulated. Only one response per council. Closing date: noon 14th August 2023.

It was RESOLVED that Members individually complete the survey and return to the Town Clerk for collation prior to submission.

C23/84 Planning Application P190111/O - Land at Flaggoners Green, Bromyard In 2021 the Town Council commissioned independent highways engineer, John Lloyd BSc (Hons) MSc MCIHT of Flow Consult Ltd to prepare a report regarding access issues in respect of the above application (Minute C21/33, 1.3.1 and P21/37 refers). This report was adopted and submitted to Herefordshire Council as the Town Council's response to the application.

At that time the Town Council resolved that Mr Lloyd be engaged to represent the Town Council at the Herefordshire Council Planning Committee when the application is considered for determination, and that event of an appeal, that he also be appointed to lead for the Town Council.

Due to the length of time that has passed, Members were requested to confirm the engagement of Flow Consult Ltd. to represent the Town Council at the Herefordshire Council Planning and Regulatory Committee when the application
